Roger discussed site considerations such as position of septic systems, and including potential changes, such as moving the basketball courts, or other proposals. Roger identified that the current Transfer Station location by the river next to Ladd Field was chosen instead of the town property on Minister Brook Rd., at least in part, due to the design of the narrow bridge crossing and truck access considerations. The Selectboard anticipates that further discussions of WNN's public shelter proposal should be addressed in coordination with the Recreation Committee that has been in process of volunteer outreach and formation by the Selectboard.
