SPEED ZONE ORDINANCE

Pursuant to 23 V.S.A. Section 1007 and based on an engineering and traffic investigation performed by Leon Magnant dated October 11, 1983, the following speed zone regulation for the Town of Worcester is hereby adopted:

Section 1. The maximum speed limit permitted for vehicular traffic on Town Highway No. 1 (Calais Road) from the junction with State Highway 12 extending easterly to the driveway of the present Maxham residence, a distance of approximately $0.60\,\mathrm{miles}$, shall be thirty (30) miles per hour.

Section 2. Town Highway No. 1 shall be appropriately posted to indicate the maximum permissible speed limit as set forth in Section 1.

Section 3. Any prior ordinance of the Town of Worcester which is inconsistent with the provisions of this ordinance is hereby expressly repealed.

This ordinance shall be entered in the minutes of the town records and shall be posted in at least five conspicuous places within town. It shall be published in either the World or the Times Argus within fourteen days of its adoption. It shall become effective sixty days after its adoption unless a petition for a voteconthe question of disapproving the ordinance is signed by at least five percent of the qualified voters of the Town of Worcester and presented to the Selectmen or the Town Clerk within forty-four days after adoption of the ordinance. If such a petition is received, the Selectmen will call a special town meeting, and the ordinance will become effective at the end of that meeting unless a majority of the qualified voters voting on the question at the meeting vote to disapprove the ordinance.

SPEED ZONE ORDINANCE

Pursuant to 23 V.S.A. Section 1007 and based on an engineering and traffic investigation performed by Leon Magnant dated October 11, 1983, the following speed zone regulation for the Town of Worcester is hereby adopted:

Section 1. The maximum speed limit permitted for vehicular traffic on Town Highway No. 1 (Calais Road) from the junction with State Highway 12 extending easterly to the driveway of the Maxham residence, a distance of approximately 0.60 miles, shall be thirty (30) miles per hour. Proceeding easterly from this point, the speed limit shall be thirty-five (35) miles per hour.

Section 2. Town Highway No. 1 shall be appropriately posted to indicate the maximum permissible speed limit as set forth in Section 1.

<u>Section 3.</u> Any prior ordinance of the Town of Worcester which is inconsistent with the provisions of this ordinance is hereby expressly repealed.

This ordinance shall be entered in the minutes of the town records and shall be posted in at least five conspicuous places within town. It shall be published in either the World or the Times Argus within fourteen days of its adoption. It shall become effective sixty days after its adoption unless a petition for a vote on the question of disapproving the ordinance is signed by at least five percent of the qualified voters of the Town of Worcester and presented to the Selectmen or the Town Clerk within forty-four days after adoption of the ordinance.
