# **NEW BUSINESS**

American Recovery Plan Act Funding – Allen Gilbert addressed Select Board about need to renew appointments for himself and John Russel (alt) to CVFiber Board. Motion made to renew both appointments by Ted, seconded by John, motion passed. Allen proceeded with thorough discussion of broadband plan for Worcester:

- Total cost ~\$950,000
- Worcester will get ~\$322,000 in ARPA funding over two years
- Progress will be accelerated by involving neighboring town
- Broadband needs to be available to all residents at a price that is affordable

Ted suggests Allen returns to Select Board when ARPA funding is clarified and a concrete proposal can be made.

**4<sup>th</sup> of July Committee -** Dell, Judy, and Caitlin reported that the 4<sup>th</sup> of July celebration is cancelled for this July but is tentatively scheduled for Sept 4, 2021. Northstar will be providing fireworks and documents requiring Select Board signature will be forthcoming. ACTION: Katie will note change of date on Town website.
