HOUSEKEEPING

Fire Department

Regional Emergency Management Committee

Cell tower

John notes a new cell tower is planned for construction at top of Norton Road. This tower would provide coverage along Rte. 12 north toward Elmore Mountain. New cell towers offer extended coverage for rural Vermont but must be constructed following Worcester ordinances. ACTION: John will provide land owner with copy of Worcester Towner Ordinance and seek additional information.
